

Schedule of Application Documents

Introduction

A hybrid planning application for the redevelopment of the Leyland Test Track site was submitted to South Ribble Borough Council in November 2017.

The application submission comprised:

- An application for full planning permission for site enabling works and the development of highway and drainage infrastructure for the full application site (“the PDS”) (Phase 1) and 197 new homes and associated internal access roads, public open space, green infrastructure and highway infrastructure (Phase 2);
- An application for outline planning permission for the remainder of the PDS for the development of up to 753 new homes, up to 5,000 sqm of Use Classes B1 accommodation; up to 15,000 sqm of Use Class B2 accommodation and up to 8,000 sqm of Use B8 accommodation, local centre comprising up to 3,000 sqm of accommodation for occupation within any combination of uses within Classes A1, A2, A3, A4, A5, B1 or D1 (including health centre / clinic) (which shall not exceed 2,500 sqm of main town centre uses), a Primary School and associated public open space and green infrastructure (Phases 3-5).

The attached schedule provides details of all application documents submitted at that time.

The documents are contained in a series of lever-arch files **numbered 1-10**.

The schedule provides direction as to the location of individual documents (i.e. the Phasing Plan submitted in November 2017 is in Application File 1).

Scheme Amendments – April 2018

In April 2018, a suite of amended and additional drawings were submitted to South Ribble Borough Council along with a further environmental information report.

The need for this submission arose from changes to the description of development and a series of minor modifications to the design of the proposed development.

The revised description of development is presented below with the changes underlined in bold:

- *application for full planning permission for site enabling works, the development of highway and drainage infrastructure for the full application site (“the PDS”) and **the provision of a car park accessed off Titan Way (Phase 1); together with the construction of** 197 new homes and associated internal access roads, public open space, green infrastructure, **an acoustic barrier** and highway infrastructure (Phase 2);*
- *An application for outline planning permission for the remainder of the PDS for the development **of between 653 and 753** new homes, up to 5,000 sqm of Use Classes B1 accommodation; up to 15,000 sqm of Use Class B2 accommodation and up to 8,000 sqm of Use B8 accommodation, local centre comprising up to 3,000 sqm of accommodation for occupation within any combination of uses within Classes A1, A2, A3, A4, A5, B1 or D1 (including health centre / clinic) (which shall not exceed 2,500 sqm of main town centre uses), a Primary School and associated public open space and green infrastructure (Phases 3-5).*

The suite of amended drawings and further environmental information **is presented within a series of lever arch files numbered 11-16**.

The scheme amendments referred to above are described in the “Other Environmental Information Report” which is contained in Planning Application File 15.

Scheme Amendments – August 2018

In August 2018 a package of further amendments to the proposed development / additional information was submitted to South Ribble Borough Council along with an updated Other Environmental Information Report and Planning Statement.

These plans and documents are presented within Planning Application **Files 17 – 24**

Scheme Amendments – October 2018

In October 2018 a package of highway information including updated plans and a revised Technical Note was submitted to South Ribble Borough Council.

These plans and documents are presented within Planning Application **File 25**

Scheme Amendments – January 2019

On 4 January 2019 a package of information was submitted to South Ribble Borough Council. These plans and documents are presented within Planning Application **Files 26 - 30**.

A further package of documents was submitted to the Council on 9 January 2019. These plans and documents are presented within Planning Application **File 31**. An updated cover letter, with reference to File 31 has been placed in File 26 for ease of reference.

Scheme Amendments – February 2019

A package of documents was submitted to the Council on 8 February 2019. These plans and document are presented within Planning Application **File 32 and 33**.

The attached schedule provides full details of all documents submitted with the original application in November 2017, the April 2018 amendments, the August 2018 amendments, the October 2018 amendments and the January 2019 amendments.

Some plans / documents supersede and replace those submitted in November 2017 / April 2018 / August 2018. Others are new plans / documents and are additional to the November 2017 / April 2018 / August 2018 submissions.

Where plans / documents are superseded this is made clear. In the example below:

- The Northern Site Access Arrangement Plan (SCP/15043/F06 Rev J) can be found in File 2, this plan was superseded in April 2018 by drawing reference SCP/15043/F06 Rev K which can be found in File 12 and superseded again in August 2018 by drawing reference SCP/15043/F06 Rev M in File 18.
- There have been no changes to the Planning Application Boundary (Location Plan) and this remains relevant. It is in File 1.
- Detailed Landscape Plan Sheet 25 (LEY1701_/PP01.25/Rev C) is an additional drawing provided in April 2018 and can be found in File 11. Revised drawings submitted in August 2018, January 2019 and February 2019 with the most up to date drawing being LEY1701_/PP01.25/Rev F in File 32.
- The Transport Technical Note 4 Rev B submitted in October 2018 is in File 25.

For ease of reference the up to date plans and documents are highlighted grey.
